### BUSINESS

#### **Request for Decision – Parkland Regional Library Budget**

Director de Bresser brought forth the Parkland Regional Library's proposed budget for the 2022 fiscal year, which proposes the membership requisition at \$8.55 per capita. This was approved by Council.

#### **Request for Decision – Proclamation for Family Violence Prevention Month**

Council proclaimed November 2021 as Family Violence Prevention Month.

#### **Request for Decision – Municipal By-election Bylaw 1263.21**

Due to a Council member vacancy, Council must hold a By-election within three months of the resignation. The By-election was called for January 10<sup>th</sup>, with two advanced vote days on January 5<sup>th</sup> and 8<sup>th</sup> as well as mail-in ballots being provided. By-election Bylaw 1263.21 received three readings and was passed.

#### **Request for Decision – Town Facility – Restrictions Exemption Program**

After recorded votes, Council decided the Town of Blackfalds will now be implementing the Restriction Exemption Program (REP) in the Abbey Centre, and the Community Centre effective Monday, November 15, 2021. All other facilities will remain at 1/3 capacity.
